LOCATION.--Lat 41°07'36", long 77°26'33", Hydrologic Unit 02050204, at the Drake Chemical Superfund Site in Castanea Township.

Owner: American Color and Chemical, LLC.

AQUIFER.--Gravel, sand, and clay of the Quaternary System.

WELL CHARACTERISTICS.--Drilled unused observation well, diameter 2 in., depth 35 ft, cased to 30 ft, screened from 30-35 ft.

INSTRUMENTATION.--Electronic data logger with 15-minute recording interval.

DATUM.--Elevation of land surface is 551.3 ft above sea level, from survey. Measuring point: Top of casing, 0.15 ft below land-surface datum.

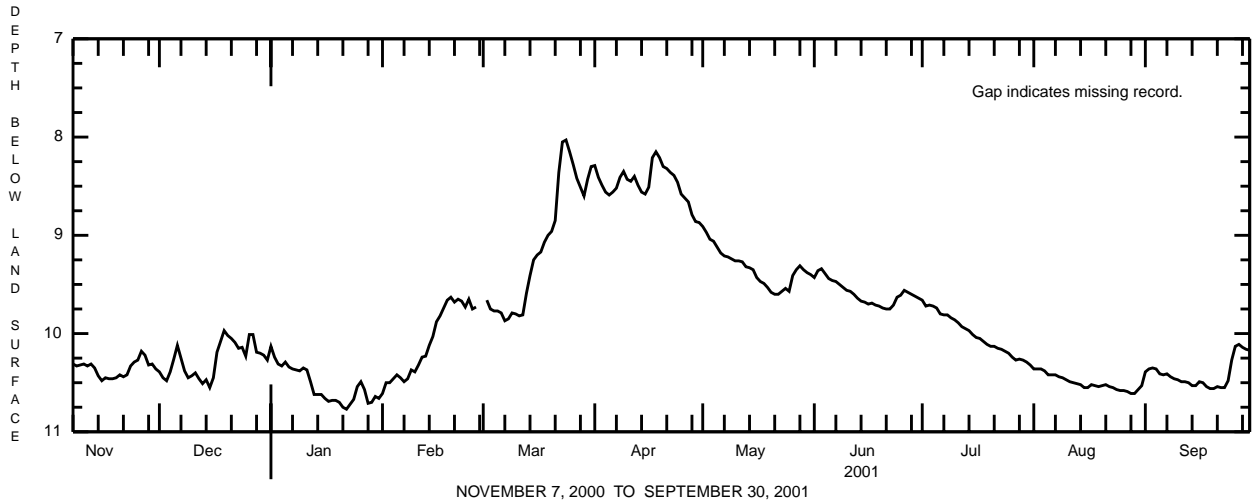
REMARKS.--In addition to the daily mean water level table shown below, daily maximum and minimum water levels are also available from the District Office.
